

*AGREEMENT*

**THIS AGREEMENT**, made this 20<sup>th</sup> day of June, 2017, by and between the City of Stevenson, a Washington Municipal Corporation, hereinafter called "Owner", and Crestline Construction Company, LLC, doing business as an Oregon limited liability company and doing business in the State of Washington as a foreign LLC, hereinafter called "Contractor".

**WITNESSETH:** that for and in consideration of the payments and agreements hereafter mentioned:

The Contractor will furnish all of the material, supplies, tools, equipment, labor, and other services necessary for the construction and completion of the project described herein.

The Contractor will commence the work required by the Contract Documents within **ten (10) calendar days** after the date of the Notice to Proceed, **but not earlier than June 23, 2017** (the "Commencement Date"), and will complete all work required by the Contract Documents within **48** working days (as defined in the Contract Documents) after the Commencement Date unless the period for completion is extended otherwise by the procedure set forth in the Contract Documents. The Contractor agrees to perform all of the work described in the Contract Documents and comply with the terms therein for the sum of **Two Hundred Twenty Six Thousand, One Hundred and Ninety Nine Dollars (\$226,199)**, or as shown in the Bid Schedule.



The Owner will pay to the Contractor in the manner and at such times as set forth in the General Conditions such amounts as required by the Contract Documents.


This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
